Field House

- ❑ Drop-off and Pick-up will all occur here
- ❑ Majority of the camp day will be spent in the Field House
- ❑ 2 Full Sized Basketball Courts
- ❑ One Full Sized Turf Field



Team Kids

- ❑ Yoga Class
- ❑ Zumba Class
- ❑ Ballet Class
- ❑ All while social distancing within our studios



Aquatics Center

- ❑ Private swim lessons will still be permitted and available for sign up. Swim instructor will be assigned to your specific child, and instructors will not be rotated. One child, one instructor.
- ❑ Lifeguards and counselors will be monitoring and ensuring social distancing within the pool and pool area.
- ❑ Equipment will be cleaned in between uses.
- ❑ “Popular” areas like the splash pad will be on a rotating schedule to ensure social distancing between children.
- ❑ Pool will be open only to summer camp children during summer camp times, no non-summer camp individuals.
- ❑ Only one age group allowed in pool are per “swim time”.





New Jersey Department of Health COVID-19 Youth Summer Camp Standards:

- 1. Ensure that camps prohibit contact sports:** Camp games will be modified to be in compliance, yet still fun! i.e. basketball games will instead become shooting, passing, dribbling skills challenges, soccer will become shooting, passing, dribbling skills challenges, all games will be modified to ensure camper safety and social distancing, smaller groups participating in games at one time, kickball space between player and base, tag the plate instead of the person, etc.
- 2. Ensure that staff and campers are educated on social distancing, hygiene (hand washing, cough etiquette), proper use of face coverings and staying home when sick:** Morning meeting for all campers while taking attendance within their groups, will be reminded of “safe” practices, hand washing, social distancing behaviors, etc. Staff will be receiving training on aforementioned safe practices.



New Jersey Department of Health COVID-19 Youth Summer Camp Standards:

3. Adequate postings of signage encouraging hand hygiene, social distancing and COVID-19 prevention materials: Signage will be up in all summer camp related areas.

4. Drop off and pick up procedures: Drop off/pick up will take place outside of fieldhouse with appropriate space in between campers, guardians, staff, etc. Drop off/pick up will be done by age group in the front of the field house. Rain day alternate procedure will also be provided. Parents “getting to work” will be given priority as much as possible this is a summer we must all work together as a “TEAM”. Times may also be staggered.



New Jersey Department of Health COVID-19 Youth Summer Camp Standards:

5. Temperature screening and health surveillance activities at entry for staff and campers. Exclude symptomatic staff/campers from site (provide isolation area for staff/campers who are already on-site that are exhibiting signs and symptoms): All staff members/counselors will be temperature screened, children will be screened at drop off, isolation area for child who is exhibiting symptoms, staff will be trained in identifying symptoms. If a child or parent is exhibiting symptoms or have a fever parents are kindly advised to not bring their child to summer camp.

6. Groups of campers (maximum of 10 indoors and 20 outdoors): 10 campers per group as of (June 15th). One counselor per group with the exception of $\frac{1}{2}$ year olds, which will have two counselors. Floating counselors will be stationed throughout fieldhouse to provide assistance, sanitation measures, additional supervision, and support.



New Jersey Department of Health COVID-19 Youth Summer Camp Standards:

7. Ensures food service avoids communal dining and stagger mealtimes: Individually packed/delivered lunches, all hygiene/safety procedures taken, lunch times staggered, lunch tables spaced. Multiple eating areas. Counselors wearing masks and gloves.

8. Routine cleaning and disinfection frequencies (deep cleaning prior to opening and after periods of closure due to positive cases): Team85 housekeeping/maintenance staff as well as summer camp employees will be ensuring facilities are properly, and frequently cleaned, areas cleaned in between camper/group usage, equipment cleaned in between camper/group usage, etc.

Additional Steps and Preventative Measures:

- ❑ Hand washing for campers when going from location to location, after games/activities. Hand washing/sanitizing will be allotted into daily camp schedule.
- ❑ Hand sanitizing stations set up throughout summer camp areas.
- ❑ Campers activities will be modified to ensure safety, hygiene, etc.
- ❑ Campers will not be allowed to mix between groups.
- ❑ Counselors will be staying with their assigned groups.
- ❑ Additional counselors hired for supervision, safety, cleaning, etc.
- ❑ No “outside” guests will be permitted in summer camp area where children will be.
- ❑ Socially distanced area for camper items/bags, etc. “Floating” counselors will be monitoring and assisting campers with getting personal items maintaining social distance, and space between campers belongings.
- ❑ Bathrooms will be monitored by counselors with limited campers allowed in restroom at a time to ensure social distancing.



Additional Steps and Preventative Measures:

- ❑ Campers are not required to wear masks when social distancing measures have been taken.
- ❑ Staff members will have masks when social distancing measures are not applicable.
- ❑ Barriers will be set up in “higher traffic areas” to ensure social distancing measures are followed.
- ❑ “Outside” area of camp will be held in parking lot this year, canopy for shade for campers, roped off area of parking lot. New area for lunch, “outdoor games - hopscotch, four square, sidewalk chalk arts and crafts, etc.
- ❑ Arts and crafts will have individual items assigned per camper so no communal supplies, no communal crafting items.
- ❑ Classes i.e. ballet, yoga, dance will be held in studio with only summer camp staff and campers, social distancing will be maintained.
- ❑ All field trips have been cancelled.



Additional Steps and Preventative Measures:

- ❑ Cubbies: Individualized for each camper. The campers will have the same location every week. They will be cleaned after each day.
- ❑ No vending machine usage: These will be off limits during the camp weeks.

Daily Schedule Example:

8:45am - 9:30am

Welcome! Check in “Morning Meeting” on Orange Court, attendance, lunch orders, reminder/discussion of “safe” practices.

9:30am - 10:15am

Orange Court - types of activities could include: volleyball with smaller teams, basketball skills challenges, four corners, floor hockey tournaments, pickleball, badminton, etc.

10:15am - 10:30am

Snack with socially distanced groups, in different areas from other groups.

Subject to change

Daily Schedule Example:

10:30am - 12:00pm

Orange Turf - types of activities could include: kickball (touching base instead of runner), soccer skills challenges, football skills challenges, wiffle ball, relay races, obstacle courses, modified versions of tags, flag football/dragon tails.

12:00pm - 12:45pm

Lunch - socially distanced groups, in different areas than other groups, individually bagged and/or individually distributed meals.

12:45pm - 1:30pm

Arts and crafts (individual baggies of crafting supplies), dance/ballet/yoga in socially distanced studio.

Daily Schedule Example:

1:30pm - 2:30pm

Blue Court - see similar activities to Orange Court

2:30pm - 2:45pm

Snack with socially distanced groups, in different areas from other groups

2:45pm - 3:45pm

Blue Turf - see similar activities to Orange Turf

3:45pm - 4:00pm

Goodbye - pick up, reminder of "safe practices" need to know for the next day at summer camp.

*Swim is twice per week, arts and crafts is twice per week, rotating small group classes available weekly, rotating outdoor activities will also be available.

*In between each time slot or activity campers will be "sanitizing" at the sanitation stations before and after rotating between areas, games, etc.
